

SPOTLIGHT: Dr. Katharine 'Kitty' Felton



July is Dr. Katharine "Kitty" Conway Felton's birth month. This month's spotlight focuses on the early years of the woman known as the "conscience of the city" of San Francisco because of her pioneering social work, genius, compassion and lasting impact upon legislation, social work and public policy in the West.

Born July 7, 1873, one of two daughters of John Brooks Felton and Kate Baldwin Felton, Kitty came from an old Massachusetts family filled with notable public figures, including her uncle Samuel Morse Felton, who is now best remembered as the man who ensured Abraham Lincoln's safe arrival in Washington for his inaugural in 1861.

Samuel Felton changed the president-elect's train route, effectively thwarting a plot to attack Lincoln's train.

Kitty's father, John Brooks Felton, was an attorney, a judge and mayor of Oakland, California. The town of Felton, in Santa Cruz County, was named for Judge Felton. According to author Jean Burton, in *Katharine Felton and Her Social Work in San Francisco*, when she was two years old, Kitty and her father were inseparable. That loving bond was shattered the next year when her father died suddenly; yet, throughout her life, people noted that Kitty was very much like her father.

As a student at the University of California, Kitty organized the first debating club. She planned to follow her father's career path and become a lawyer. However, her first year at Stanford Law School was also her last; she left in search of her true calling. In 1897, she became a graduate student at the University of Chicago as a fellow in political economy and lived at Hull House, the ground-breaking settlement founded by Jane Addams. In Chicago, Katharine saw her first impoverished neighborhoods, was involved with social work and experienced organized charities. It laid a great foundation for the work she began as director of the agency known then as Associated Charities, and now as Felton Institute, in 1901. Kitty Felton drafted nearly all of California's early legislation covering welfare and relief, according to the Proceedings of the National Conference of Social Work, Volume 13, 1901. As a child, Kitty heard predictions about a fearful earthquake coming, and when a small one hit, she placed her cat in her doll carriage and tied the leashes of her three dogs to her tricycle to steer her beloved pets to safety. When the Great Earthquake of 1906 hit, her leadership and initiative led to the development of mental health counseling for the traumatized, transition of nearly everyone in refugee camps into shelters, and the creation of the first employment agency in the United States. These innovations became known as the "San Francisco Model" by 1907.

Dr. Katharine 'Kitty' Felton's incredible legacy lives on today in the more than 50 programs of life-transformative mental health and social services that Felton provides for people of all ages in need who come from every walk of life.

As the spokesperson for ABC's literacy campaign, Spencer wrote and published a series of children's books, including *Can It Really Rain Frogs? The World's Strangest Weather Events* **and** *Shake, Rattle, and Roll: The World's Most Amazing Volcanoes, Earthquakes, and Other Forces.* Spencer enjoys inspiring youth and devotes many hours to participating in community events.

Young graduates from Felton's Learning Center, Dr. Martin Luther King, Jr. Center, and Family Developmental Center will don purple gowns and mortarboards as they celebrate this milestone. Al Gilbert, Felton President and CEO, Yohana Quiroz, COO of Children, Youth and Family and Transitional Age Youth and parents will share words of advice at this year's celebration. Students from each site will perform songs or poems at what promises to be a jubilant event. This is the second year that Cradle to College has been held at San Francisco State University's campus.

Felton Ombudsman Program: Advocates for the Elderly, the Greatest Generation

Kitty Felton was a champion for children, especially orphaned children, but she didn't stop there. She cared about and provided services for people of all ages, from birth to the elderly. Kitty set a precedent of focusing on providing for people in need of social services at all ages and stages of life. Today, Felton Institute continues her great legacy.



Among our many award-winning programs that we are proud to offer is Felton's Long-Term Care Ombudsman Program for San Francisco, which serves elderly people and dependent adults living in long-term care facilities. Our Ombudsman Program investigates complaints of abuse and resolves issues affecting elderly and dependent adults in long-term care facilities; investigation is mandated by federal and state law.

In addition, the Ombudsman program provides advocacy and support to help people transition from home to hospital or a skilled nursing facility when assistance is needed. The most difficult transitions often involve moving from being well to being medically compromised.


Long-Term Care Ombudsman Program for San Francisco was created by the Older Americans Act (OAA). OAA supports a range of home and community-based services, including elder abuse prevention and caregiver support. The Ombudsman Program receives and investigates complaints regarding the welfare, health, safety and rights of residents of nursing homes, assisted living facilities, or hospital discharge units. Staff and field Ombudsmen are trained professionals who are certified by the State of California to carry out the duties according to the Ombudsman laws. Volunteer Ombudsmen regularly visit long-term care facilities to provide supportive, friendly contact with residents, improving their daily experience. Complaints about the care of residents may be made by the resident or by someone else. Anyone can contact us on behalf of a person in nursing or residential facilities. Ombudsman services are free and confidential.
